

In order to better serve our customers, the Arizona Department of Agriculture will use the [www.azda.gov](http://www.azda.gov) webpage to advertise all Brand applications for a period of 30 days prior to awarding the Brand. Please notice the “End Date” on the advertising page. All protests or objections must be postmarked before the “End Date” for the specific Brand in question. Protests that are postmarked after the End Date will not be considered. All protests must be received in writing. Phone protests will not be considered.

Every month we average 200 Brand renewals. Every month, we get a percentage of renewal notices back as undeliverable. While it is the responsibility of the Brand owner to notify the Department of any change in address, we realize that when a Brand only renews every five years, it can be difficult to remember everyone that needs to be notified of a change of address. We ask that our customers keep an eye on the [expired Brand page](#). All protests or objections must be postmarked before the "End Date" in the chart below. Protests that are postmarked after the End Date will not be considered.
